Notes:

01. Students wishing to join in April/May would need to pay a pre-term fee in addition to the Annual School Fee.
02. The Composite Fee does not include Uniforms, text books, annual camps, charges for external examinations, additional subject support/individual activity tuition (if applicable), off campus sports/ activities, college applications, specialized individual projects in Design & Technology/Visual arts /Sciences, Insurance etc.
03. To meet the expenses towards items listed above, all students are required to maintain a Contingency Deposit of Rs. 15,000. New joiners need to additionally deposit a sum of Rs. 10,000 to cover various expenses /purchases while joining.
04. The IB Career-related study fee is non-refundable and non-transferable as per SCAD and SUMAS.
05. **Rebates:**
 - **Annual Payment Upfront:** 5% on Composite School Fee. Please note that all various fee/charges for the entire year need to be paid upfront (by 15 May) to avail this rebate.
 - **Student Siblings:** 10% on Composite School Fee and Transport Fee. These rebates are available to the younger sibling(s) till the time the elder sibling is a Pathways student / school transport user.
 - **Alumni Children:** 50% on one-time Admission Fee.
06. Payments arriving after expiry of Pay By Date shall attract Late Fee Payment Penalty @ 2% per month. Payments not arriving within 45 days of Pay By Date shall result in cancellation of admission.
07. Transfers/ Withdrawals should be advised by 30th November for end of 1st semester withdrawals or by 30th April for end of year withdrawals failing which 'Notice Period Fee' equivalent to two installments of the Composite School Fee applicable for the semester shall be charged.
08. Annually an incremental amount shall have to be deposited to bring the level of Security Deposit at par with two installments of the then applicable Composite School Fee.
09. Though the Fee is denominated in INR, Parents residing outside India need to pay the same in equivalent foreign currency based on the exchange rate in force at the time of payment.
10. You may remit payment online by visiting www.pathwaysnoida.edu.in/feepayment or payment by cheque/demand draft should be made in favour of "Pathways School Noida Revenue Account". Please write student's name and ID no. on the reverse face of the cheque.
11. The Fee Structure of Pathways School Noida is governed by the rules, policies, terms and conditions as detailed in the Parent Student Handbook and as amended from time to time by the School Management at its sole discretion.
